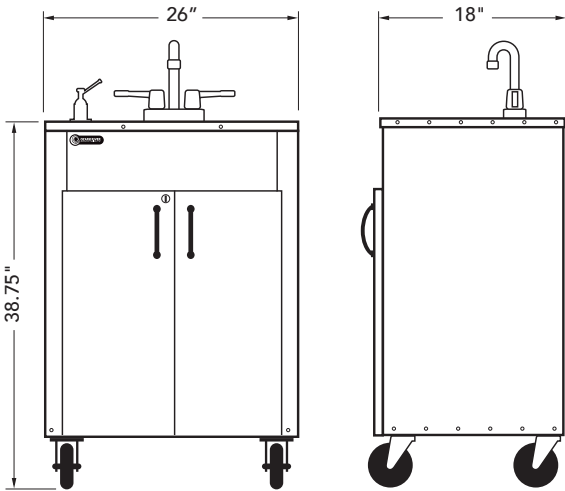


## ELITE LS 1
