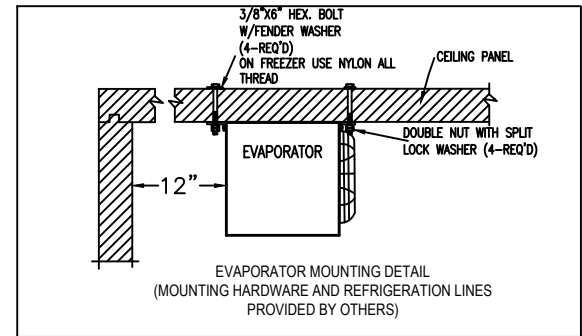
**PLAN VIEW**
